



## CALLING FOR SUBMISSIONS FOR NEXT YEAR'S 20TH ANNIVERSARY HEAVEN CAN WAIT 5K DESIGN!

To celebrate 20 years of Heaven Can Wait 5K, St. Charles Foundation is hosting a contest for the 2019 design for this beloved community event. We are seeking design submissions from local Oregon residents to be used on promotional materials, both print and digital, as well as merchandise including the race shirt — a highly anticipated and visible item each year! The design will help us raise funds for Sara's Project, providing education, early detection and patient support services for those facing breast cancer in our region. Please read the full rules and submission requirements.

### HOW TO ENTER THE CONTEST:

The contest begins on **Monday, October 1, 2018**. Submissions will be accepted through **Friday, January 4, 2019**. Winner will be announced via our website, social media and by direct contact to the winner's email account. In order for your entry to be accepted and reviewed by our judges, all entries must be:

- 1) Submitted in a digital format by the deadline directly to [giving@stcharlesfoundation.org](mailto:giving@stcharlesfoundation.org). Subject line or written title should read "Heaven Can Wait 5K 20th Anniversary Design Contest [your last name]"
- 2) Submissions may be submitted as a high resolution .PDF with 300dpi or higher.
- 3) Submissions must also include the original source file, ideally scalable vector graphic in .EPS or .AI format.
- 4) Hand drawn submissions may be accepted if St. Charles Foundation is able to convert them into a viable digital format.
- 5) There may be no more than two entries per entrant.
- 6) Entries must include name, age and contact information.
- 7) Entrants under the age of 18 must have a parent/legal guardian represent them, and included name, age and contact information for the parent/legal guardian.

### DESIGN REQUIREMENTS:

- Professional: This design will be featured on our website, our social media platforms and promotional materials (t-shirts, posters, etc). While we want the design to be eye-catching, it must also be legible.
- Theme: There is no specific theme for the design. In past years, the Heaven Can Wait 5K design has featured elements from nature (flowers, birds, trees), those related to breast cancer awareness and education, race-related objects, such as running shoes, and often a combination of more than one of those categories along with symbolism for the event. This year is the 20th anniversary. While it is not required that those words are included, the anniversary may be used as a design element.
- Color: Colors should be limited to no more than four, or black and white. Color may be added by St. Charles Foundation for black and white submissions.
- Integrity: Designs cannot contain copyrighted material. Designs must have been created and edited by the contestant(s). Must be easily reproducible and scalable for large and small formatting. All entries will become the sole property of St. Charles Foundation, and will be displayed publicly. The winning entry will be used as the design for the 2019 Heaven Can Wait 5K, and the entrant agrees to transfer all rights and title to the entry to St. Charles Foundation.

## **THE WINNING DESIGNER WILL RECEIVE:**

- 1) Four complimentary registrations for the 2019 Heaven Can Wait 5K
- 2) A unique gift with the winning design printed on it
- 3) The right to use the basic design and identify her/himself as the designer

***All finalist designers will also be acknowledged.***

For entrants under the age of 18, there will also be design winners. These images may be printed on various mediums and displayed on the St. Charles Foundation website and social media. The first place winner will receive:

- 1) Two complimentary registrations for the 2019 Heaven Can Wait 5K.
- 2) A unique gift with their design printed on it.

## **JUDGING AND SELECTION OF WINNER:**

All entries will be judged by the Heaven Can Wait 5K organizing committee and the staff of St. Charles Foundation, who will nominate finalists and choose a winner. St. Charles Foundation has the right to disqualify an entrant or entry at its sole discretion. The winners or winners' parent/legal guardian will be required to sign a contract assigning all ownership of the design to St. Charles Foundation. Entering constitutes permission for St. Charles Foundation to make public and otherwise use the winners' name for publicity purposes. Further personal data may be requested but not required.

## **ACCEPTANCE:**

Participation constitutes the Entrant's full and unconditional agreement to and acceptance of these Official rules. By participating in the Contest, the Entrant is representing and warranting that he/she has read and understood, and agrees to be bound by, these rules. Including the guides and rules referred to herein, these Official Rules constitute the entire agreement between the Entrant and St. Charles Foundation in relation to the Contest. They govern the Entrant's participation and supersede any prior or other agreements between the Entrant and St. Charles Foundation and relating to the Contest.
